

RESOLUTION NO. 09-601

A RESOLUTION OF THE CITY OF KECHI, KANSAS; ESTABLISHING FEES AND CHARGES AUTHORIZED PURSUANT TO THE CITY CODE FOR SERVICES RELATED TO CONTRACTOR LICENSING & BUILDING INSPECTION; ADMINISTRATIVE SERVICES; OPERATION OF MUNICIPAL COURT SERVICES; POLICE RECORDS; AND OTHER SERVICES RENDERED BY OR THROUGH CITY FORCES, EXCLUSIVE OF FEES ESTABLISHED RELATING TO ZONING & SUBDIVISION REGULATIONS; RESCINDING ALL RESOLUTIONS IN CONFLICT INCLUDING RESOLUTION 09-402.

WHEREAS, the Governing Body of the City of Kechi, Kansas (the "City") is authorized to establish by resolution various fees and charges to be paid in connection with requirements imposed or services provided pursuant to the City code;

WHEREAS, the Governing Body has heretofore adopted its resolution no. 98-402 establishing such fees and charges, has from time to time amended specific provision of the same, and now desires to repeal said resolution no 98-402 and all amendments thereto and to substitute therefore the fees and charges for those established therein;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF KECHI, KANSAS:

Section 1. Fee established. As authorized by the City code adopted by ordinance 1628-09, the following fees and charges are hereby established for the various requirements and services provided for or authorized by the Kechi City Code and or other ordinances of the City, as the same may from time to time be amended.

Section 12. Repealer. Resolution no. 98-402 of the City of Kechi and all resolutions amending any portion thereof are hereby repealed.

Section 13. Effective Date. This resolution shall take effect and be in force January 1, 2010.
